DISTRICT HIGHLIGHTS



Allocated \$52,587 through the NC Ag Cost Share Program for landowners to install water quality practices.

Completed 11 debris removal projects in the French Broad River with \$38,290 in funds.





Rented the ag equipment to 26 landowners.

Gave 45 classroom presentations and had over 800 posters completed, and nearly 200 essays written for our contests.





Had 3 **Area 1** conservation contests winners and **1 state** contest winner!

Conducted our 48th annual conservation field days for Brevard MS and Rosman MS seventh graders.

Hosted the annual awards banquet and honored award recipients and volunteers.




DISTRICT CONSERVATION

NC AG COST SHARE PROGRAM

During fiscal year 2018-2019, the District allocated \$39,087 in regular assistance funds and \$13,500 in TV2 drought funds to landowners in Transylvania County for Best Management Practices that improve water quality. The practices installed and planned during this fiscal year will save an additional 1,173 Tons of sediment on 190 acres, from going into our stream and rivers. These funds were applied as follows:

NRCS CONSERVATION

The Natural Resources Conservation Service (NRCS), is an agency under the U.S. Department of Agriculture. We offer technical and financial assistance to agricultural producers to put conservation practices on the land. There are a wide variety of practices that can be utilized to address resource concerns including, but not limited to, fencing (exclusion and interior), livestock watering tanks and pipeline, creek/stream crossings, cover crops, prescribed burning. We also work with producers to help enhance pollinator habitat on their land.


The Environmental Quality incentives Program (EQIP) is one of the programs agricultural producers utilized for financial assistance to install their conservation practices. EQIP conservation plans can address issues on many different land use types, including pasture-land and grazing systems, cropland, forestry and even wildlife. EQIP supports the conservation priorities established by the Transylvania County SWCD.

The year 2018, as a whole, brought many environmental hardships, with flooding being the most prominent and devastating one. In the midst of it all, the producers were still able to put Conservation BMPs on the ground to protect our vital resources. In FY 2019 we **installed** 3,416 linear feet of fence, 1,050 linear feet of livestock pipeline, 21 acres of prescribed grazing, 5 livestock watering tanks, 1600 square feet of Heavy Use Area Protection and 1 Seasonal High Tunnel through the EQIP program. Any agricultural producer can be eligible to participate in the EQIP program and would need to contact the local NRCS office for details.

DISTRICT CONSERVATION

COMMUNITY CONSERVATION

This year, The District planned a **50 feet long streambank restoration project** on King Creek. The project will save approximately **81 Tons** of soil each year from entering King Creek. The District has also **helped many landowners** in a variety of ways including: erosion control and seeding information, streambank stabilization, culvert installation and pasture management recommendations. Staff also referred many landowners to the Divisions of Water Quality or Land Quality if they had issues that needed enforcement authority.



EQUIPMENT RENTAL





Thanks to previous TVA grants, we have a lime spreader, conservation seeder, fertilizer spreader, 2 weed wipers, manure spreader, post auger and driver, and a trailer to haul the equipment. Farmers have been very receptive to the rental equipment and are glad to have access to this equipment to make improvements to their fields and pastures.

For FY 2019, the equipment was rented by **26 landowners, for a total of 36 days** for use on about **750 acres**. Rental fees/charges **brought in \$1,670** which was set aside in a reserve account for maintenance and repair of the equipment.



DISTRICT CONSERVATION

COUNTY DEBRIS REMOVAL

The district received \$25,000 from County Commissioners, \$20,000 from the state, and \$10,000 from the Transylvania Tourism Development Authority to remove debris from the French Broad River in the county. The district was able to complete 11 projects that affected 665 linear feet of streambank. Large trees and other debris are not only causing severe erosion on streambanks, but are also safety hazards for recreational users of the river. 


