# TRANSYLVANIA COUNTY TRANSPORTATION ADVISORY COMMITTEE MINUTES February 12, 2024, 6:00 PM

I. Welcome: Mr. Scott McCall called the meeting to order at 6:00 PM. Present were Mr. Scott McCall, Mr. Jimmy Whitmire, Mr. Ken Frady, Mr. Rick Lasater, Mr. Harold Paxton, and Mr. Keith Wilmont. Also in attendance were Mr. Howard Granat, Mr. James Felty, Mr. Troy Wilson, and Mr. Steve Williams from North Carolina DOT. Ms. Vicki Eastland, representative of the Land of Sky RPO, was present. Transylvania County staff present included Ms. Darby Terrell, Planner. Two members of the public were present.

#### II. Public Comment:

<u>Larry Chapman:</u> Mr. Chapman, attending as a citizen, shared a complaint received over a year ago from a concerned citizen. The complaint included pictures of what appeared to be NCDOT workers cleaning up around a bridge. One photo showed them picking up debris, while another showed them dumping it on the other side of the bridge. Mr. Chapman was unsure what could be done but wanted to inform the committee. (Attachment 2)

#### III. Agenda Modifications:

There were no agenda modifications.

#### IV. Consent Agenda:

**A.** Minutes (July 9, 2024)

The Chair, Mr. McCall, requested a motion to approve of the changes discussed, which were striking out Mr. Whitmire's nomination and another correction as the chair was Mr. McCall in the Consent Agenda paragraph, in the July 9, 2024 meeting minutes. Mr. Lasater motioned to approve the minutes with changes discussed, seconded by Mr. Wilmont. The motion passed unanimously.

#### V. Presentation

A. NCDOT i-40 and US 74A Update: Steve Williams

Mr. Steve Williams of NCDOT Division 14 presented an update on NCDOT's current goals and progress on roads and areas drastically impacted by Hurricane Helene. This included I-40 between Asheville and Tennessee, as well as Chimney Rock and Gerton for US 74A. Mr. Williams informed the board that NCDOT is on an aggressive two-year rebuilding plan for these areas and outlined the issues they are facing.

#### VI. Old Business:

#### **A.** Transylvania County Comprehensive Transportation Plan (CTP):

Mr. Williams updated the Committee that a draft was sent to the Land of Sky RPO and Transylvania County staff for their corrections and changes. He informed the Committee that many changes were needed by Daniel Sellers, which is why the draft hasn't been shared with them yet. The draft is still not ready for Committee review, hence only staff have reviewed it.

#### B. NCDOT Current Projects Update

Mr. Williams provided an update on current and upcoming construction projects. He mentioned that some construction dates might be pushed back and highlighted the last column created to show where certain projects landed in the 2026-2035 STIP Draft. He informed the Committee of projects that have been pushed out of funding and noted that the Division's total budget has increased, leading to a larger deficit, which was expected by NCDOT Division staff.

Mr. Williams reminded the Committee that projects appearing close to completion on the table are not yet closed due to vegetation around the projects. The road work is complete, but the project remains open until the vegetation aspect is finished.

During the discussion, Committee members asked NCDOT clarifying questions about projects on the documents and others not listed

#### C. LOSRPO Updates:

Mr. Williams updated the committee on Prioritization, which occurs every two years. He informed the committee that they are about to start the process on P7 since the draft was just approved. Projects not committed next to them will need to be resubmitted for funding consideration. He stated there is a list of projects created for the county, which can be reviewed during this process.

Mr. Whitmire mentioned some roads that should be fixed. Mr. Williams explained that these roads haven't been considered due to lack of funding or not being flagged as safety areas due to crashes. He suggested reaching out to Mr. Wilson's office.

#### D. Transit Ridership: Yearly Numbers for Fixed Route and Demand Response

Ms. Darby Terrell presented charts and an update on the current state of Transportation. She informed the board of plans to change Fixed Route stops and the current survey open for public feedback. Ms. Terrell discussed improvements the department is trying to implement, including increased marketing, changing Fixed Route stops, and other ideas. During the discussion, members asked questions about driver feedback, areas needing service, and popular destinations.

#### VII. Public Comment:

<u>Larry Chapman:</u> Mr. Chapman asked Mr. Troy Wilson when NCDOT plans to fix Becky Mountain Road. Mr. Wilson responded that a contract should be in place within the next two to three weeks. He stated that if prices are reasonable, they can let the contract, but he is not optimistic due to higher construction prices seen for multiple storm repair projects.

#### VIII. Committee Members' Comments:

<u>Jimmy Whitmire:</u> Mr. Whitmire asked NCDOT questions on the FEMA debris pickup, due to him seeing a lot of piles left without proper cleanup. He wanted to know when Soil and Water could come to clean up instead. He is concerned that the next high water will wash away the piles. Mr. Whitmire wanted to know who oversees these crews.

Mr. Troy Wilson of NCDOT answered it is out of NCDOT's realm, the crews are not contracted out to NCDOT. Mr. Wilson also directed Mr. Whitmire to the County Manager Jaime Laughter, since she is the contact for FEMA debris pickup for the county. He cautioned Mr. Whitmire there are multiple phases of the debris removal and will take more than six months to a year at least. A discussion continued on this topic.

<u>Harold Paxton:</u> Mr. Paxton shared photos of the FEMA debris pile that Mr. Whitmire talked about. (Attachment 2)

<u>Scott McCall:</u> Mr. McCall mentioned the process for cleanup has stepped up since the visit from Trump. He mentioned the Army Corp of Engineers deadlines have been moved to June and July with some of the cleanup projects.

Mr. Chapman mentioned they had received an update in Asheville that the Army Corp has contracted out to three different contractors to focus on debris removal. Mr. Chapman warned them that Transylvania County will not be a top priority with so many other damaged communities in other counties. Mr. Chapman stated that they did receive a guarantee that the debris pickup will not be put in the County's landfill.

Multiple committee members and Troy Wilson began discussing more on the debris clean up and the processes that are being followed.							
	r. Lasater moved to adjourn the meeting. Mr. Wilmont seconded the motion. The motion ssed unanimously, and the meeting was adjourned at 7:13 PM.

We closed out the Fixed Route Survey with close to 200 responses. We are now compiling the data we have received into a report which will be available at the

next meeting.

The ride count for this past quarter has gradually increased, marking the end of the seasonal downturn. Fixed Route ridership saw a steady rise from January to March, increasing from 130 rides per month in January to 142 rides per month in March. Demand Response ridership also grew significantly, as anticipated, from 1,245 rides in January to 1,699 rides in March. Notably, the March figures

for Demand Response are the second highest in the past four years.

















## **Transylvania Crashes by Emphasis Area**





## Transylvania Fatal and Serious Injury Crashes by Emphasis Area





