# **DISTRICT HIGHLIGHTS**



Allocated \$26,645 through the NC Ag Cost Share Program for landowners to install water quality practices.

**Planned and installed 6 new contracts and** obligated **\$592,769.00** in Transylvania County for conservation BMPs.





Completed 25 debris removal projects in the French Broad River with **\$45,925** in funds.

Rented the ag equipment to **20 landowners** for use on **273 acres**.





**Partnered** with the US Forest Service, Transylvania County and the NC Dept. of Agriculture in the **Good Neighbor Program** for the third year.


The district **secured federal and state grants** to help repair the damage left by Tropical Storm Fred.





Offered virtual presentations and had over 50 posters completed, and 8 essays written for our contests.



#### NC AG COST SHARE PROGRAM

During fiscal year 2021-2022, the District **allocated \$26,645 in cost share assistance funds** to landowners in Transylvania County for Best Management Practices that improve water quality. These funds were applied as follows:

These BMPs helped to save **66 Tons of soil**, **180 pounds of phosphorus** and **360 pounds of nitrogen** from polluting our streams.






# **DISTRICT CONSERVATION**

#### **TROPICAL STORM FRED**

On August 17<sup>th</sup>, 2021, Tropical Storm Fred produced rainfall amounts that caused damage to several areas of the county. In the Balsam Grove community, several bridges were washed out or damaged along with streambank erosion and debris jams. Sapphire and Toxaway also sustained damage to several road culverts along with some severe landslides. The storm also contributed to several debris jams and streambank erosion along the French Broad River from Rosman to Penrose. Once the Emergency Watershed Protection Program was approved for Transylvania County through the Natural Resources Conservation Service, Jeff Parker and a representative from the Madison County SWCD viewed a list of damaged sites provided by the county Emergency Management Services and Fire Marshall's office. Out of all the sites reviewed, NRCS approved 6 sites for streambank stabilization. The Grant and Agreement Award was in the amount of \$597,176, which is 75% of the estimated construction cost and 10% of the engineering cost.

On July 5, 2022, TSWCD received notification from the Commissioner of Agriculture's office of the Funding Offer of \$307,371 through the new program from the Division of Soil & Water Conservation called the Streamflow Rehabilitation Program (StRAP). It was set up to cover the remaining 25% of construction costs of the EWP program.

With costs for most things being higher than usual, it is estimated that engineering will probably cost 20% of construction costs, resulting in a shortfall of about \$28,525. The NC Department of Public Safety will provide the funds needed to bridge this gap and has approved an additional \$75,000. At the printing of this report, the county has an RFQ advertised to find an Engineering Firm to design repairs needed and assist with the reporting requirements of the EWP and StRAP programs.

# **DISTRICT CONSERVATION**

#### COUNTY DEBRIS REMOVAL

The district **used \$45,925 from County Commissioners** to remove debris from the French Broad River in the county. The district was able to **complete 25 projects** that **affected approximately 825 linear feet** of streambank. Large trees and other debris are not only causing severe erosion on streambanks, but are also safety hazards for recreational users of the river. #### GOOD NEIGHBOR PROGRAM

The District is honored to be partnering with the US Forest Service and Transylvania County in a pilot program called the "**Good Neighbor Program**". This project will replace an existing ford-type crossing and footbridge in the Cove Creek area of the Pisgah National Forest with an arch style "aquatic organism passage". The new structure will eliminate contaminants from vehicular traffic and improve water quality for many organisms, including the 3 species of trout that are found in this stretch of stream.



#### EQUIPMENT RENTAL

Thanks to previous TVA grants, we have a lime spreader, conservation seeder, fertilizer spreader, 2 weed wipers, manure spreader, post auger and driver, and a trailer to haul the equipment. Farmers have been very receptive to the rental equipment and are glad to have access to this equipment to make improvements to their fields and pastures.

For FY 2022, the equipment was rented by **20 landowners, for a total of 27 days** for use on about **273 acres**. Rental fees/charges **brought in \$1,300**, which was set aside in a reserve account for maintenance and repair of the equipment.



# **NRCS CONSERVATION**

The Natural Resources Conservation Service (NRCS), is an agency under the U.S. Department of Agriculture. We offer technical and financial assistance to agricultural producers to put conservation practices on the land. There are a wide variety of practices that can be utilized to address resource concerns including but not limited to Fencing (exclusion and interior), Livestock watering tanks and pipeline, creek/stream crossings, cover crops, prescribed burning. We also work with producers to help enhance pollinator habitat on their land.

One of the main Farm Bill Programs that NRCS administers is the Environmental Quality Incentives Programs (EQIP) to assist landowners in applying conservation best management practices (BMP's) on their working agricultural lands. EQIP supports the conservation priorities established for the Transylvania County SWCD. BMP's are used to correct natural resource concerns on a variety of land uses, including pasture, cropland, and forestland. NRCS uses technical, engineering, and financial resources to assist landowners with these projects.

Another Farm Bill Program that NRCS administers is the Conservation Stewardship Program (CSP) which is a voluntary program that encourages agricultural producers to improve conservation systems by improving, maintaining, and managing existing conservation activities and undertaking additional conservation activities.

During the 2021/2022 Program Year, NRCS obligated **\$592,769.00** to **6 new contracts** in Transylvania County. These contracts contain best management practices including livestock watering systems, stream crossings, exclusion fencing and stream restoration. They are contracted on a total of **224** acres of farmland in Transylvania County.

Best management practices that have been installed in Transylvania County over the past year include pasture management practices such as livestock watering systems, fencing, and heavy use area protection, along with grassed waterways and grade control structures for erosion control on crop land.

Emergency Watershed Protection Program (EWP). This program is administered by NRCS during times of natural disasters such as Tropical Storm Fred that impacted Transylvania County in August, 2021. To date, over **\$640,000.00** has been secured to assist with recovery efforts in Transylvania County. This will include stabilization and repair of critically failing stream banks that are impacting roads, houses, and bridges along with removal of debris that has been deemed an eminent threat to life or property.





# **CONSERVATION EDUCATION**

#### **POSTER CONTESTS**

Due to continued restrictions from CoVID-19, Jo Ann McCall, Education Coordinator, developed and distributed a virtual presentation on the contest theme, "Soil and Water...Yours for Life." The district received several posters, essays and computer slide show presentations.




