MINUTES

CALL TO ORDER

- I. <u>WELCOME:</u> Chair Kimsey Jackson called the meeting to order at 6:00PM. Vice Chair Lauren Wise, Mrs. Karen Gleasman and Mr. Scott Sullivan were also present. Mr. Rick Lasater (excused), Mr. Beecher Allison (excused) and Mr. Terry McCracken (excused) were absent. A quorum was present.
- II. <u>PUBLIC COMMENT (15-minute time limit. Speakers are limited to three minutes.)</u>: There were no public comments.
- III. AGENDA MODIFICATIONS: There were no agenda modifications.

IV. <u>CONSENT AGENDA</u>:

A. Minutes (September 16, 2021)

B. Subdivision Approval and Updates

After a brief discussion and clarification of the presented information, <u>Mr.</u> <u>Sullivan moved to approve the consent agenda in its entirety, and Mr. Wise</u> <u>seconded the motion. All present members voted in favor, and the motion</u> <u>carried.</u>

V. PRESENTATIONS/ RECOGNITIONS

A. <u>Transportation Update</u>: Mr. McNeill presented Transportation updates involving NCDOT and Land of the Sky RPO. He explained the process for the state choosing transportation construction projects, based on safety and efficiency. He also explained that cities can perform small scale construction projects such as potholes or repaving. NCDOT projects can be planned and approved years in advance, but pricing can change between a project's approval and beginning construction. Of the five approved upcoming projects, some might have reduced funding. Transylvania County's Fixed Route service

also recently increased its number of clients. Mr. McNeill answered the Board's questions about the fixed route service, and its possible future expansion to other areas of the county.


B. <u>Community Appearance Initiative Introduction:</u> Mr. McNeill explained the Transylvania County Tourism Authority approved \$20,000/year of funding for the new Community Appearance Initiative, for a period of three years. He explained the next steps in appointing the Committee. Transylvania County had a Community Appearance Initiative 10+ years ago. He explained the project helps owners clean properties when they are financially or physically unable to do so. The goal is to improve the aesthetic, safety, and cleanliness of properties in the county, that are visible from public roads. The project was reinstated due to public request. Mr. McNeill expressed the likelihood of asking a Planning Board Member to sit on the new Community Appearance Committee.

VI. <u>NEW BUSINESS:</u>

- A. Director's Report: Mr. McNeill informed the Board of the Transylvania County Commissioners' vote to table the Cedar Mountain Small Area Plan at their recent meeting. He also announced Ashley Minery had moved the Planner position. The Administrative Support Specialist position is vacant, so the Planning Department still does not have a full staff. The next Planning Board meeting is scheduled for December 16, 2021 at 6:00PM. The Board briefly discussed the possibility of cancelling the December meeting due to the holidays and staffing shortages, but no decisions were made.
- VII. <u>PUBLIC COMMENT</u> (15-minute time limit. Speakers are limited to three minutes.): There was no public comment.
- VIII. BOARD MEMBERS' COMMENTS: The Board discussed the Board of Commissioners' consideration process of the Cedar Mountain Small Area Plan and the Planning and Transportation Departments' current staffing positions. The Board also discussed public feedback they had received about Small Area Plans and their future role in Transylvania County. The Board also discussed a noise ordinance update it previously approved and sent to the Board of Commissioners for consideration. Mr. McNeill discussed his ambitions to unify the county's land use ordinances into a single document and update others, outside of the recently fulfilled 160-D update requirement. Ms. Gleasman motioned to adjourn the meeting, and Mr. Wise seconded the motion. All present members voted in favor and the meeting was adjourned at 7:08PM.
