CALL TO ORDER

- I. WELCOME: Mr. Lauren Wise called the meeting to order at 6:00PM. Mr. Kimsey Jackson, Mr. Beecher Allison and Ms. Karen Gleasman were also present. Mr. Scott Sullivan and Mr. Rick Lasater were absent. The Planning and Community Development Department staff Ms. Ashley Minery was in attendance. A quorum was present.
