# MINUTES

#### **CALL TO ORDER**

- I. WELCOME: Mr. Lauren Wise called the meeting to order at 6:00PM. Mr. Rick Lasater, Mr. Kimsey Jackson, and Ms. Karen Gleasman were also present. Mr. Beecher Allison and Mr. Scott Sullivan were absent. The Planning and Community Development Department staff Mr. Allen McNeil, Ms. Ashley Minery, Ms. Darby Terrell and Mr. Liam McKissock were also present. A quorum was present.

### IV. PRESENTATIONS

# A. Comprehensive Planning

Mr. McNeill gave a presentation on state requirements for Planning Boards' role in writing and updating comprehensive plans. He also discussed popular areas of concern for comprehensive planning. Currently the TDA is providing \$20,000/ year for 3 years for the initiative. The program will be advertised and will be executed on a voluntary basis only. The county will provide staff time as their contribution to the program.

- B. <u>Director's Report:</u> Mr. McNeill announced that he would be leaving his position. He also announced that Ms. Darby Terrell had returned to the Planning Department staff as the Transportation Planner. The next meeting will be held on September 15, 2022 at 6:00PM.
