In accordance with the Transylvania County Planning and Development Charter, Section 16-28, subsection (b), in April of each year the Planning Board is tasked with reviewing the County's current comprehensive plan. At their regular meeting on Thursday, April 15th, 2021 the Planning Board began their annual review process for the year 2021, completing their review at their regular meeting on Thursday July 15th, 2021.

The following is the Planning Board's formal account of their 2021 annual review of the 2025 Transylvania County Comprehensive Plan to be submitted to the Transylvania County Board of Commissioners for Consideration.

2025 Comprehensive Plan Objectives the Planning Board felt **significant progress had been made** since the plan's adoption toward the objectives below.

- Focus Area 1, Objective 1: Transylvania County actively supports efforts to promote and grow existing businesses and create places and policies to attract new businesses.
- Focus Area 2, Objective 2: Transylvania County promotes and protects a diversity of agricultural, work lands, and forestry operations throughout the county.
- Focus Area 3, Objective 3: Transylvania County Promotes exceptional community facilities throughout the county.
- Focus Area 4, Objective 5: Transylvania County supports life-long learning and personal advancement that enables the county to retain an educated workforce and maintain the high-quality of life.

2025 Comprehensive Plan Objectives the Planning Board felt **not enough progress has been made** since the plan's adoption toward the objectives below.

- Focus Area 1, Objective 2: Transylvania County initiates efforts to maintain and enhance infrastructure in order to improve our unique quality of place.
- Focus Area 4, Objective 1: Transylvania County Values the physical and mental health of all citizens, and is recognized as a leader in Western North Carolina for actively providing access to excellent health care facilities and services.

• Focus Area 4, Objective 2: Transylvania County recognizes and actively advocates for the diverse interests and cultures of the community and fosters cooperation between citizens and communities throughout the county, while valuing the county's rich cultural and historic heritage.

The Planning Board also included in their annual review general observations of topics related to contents of the comprehensive plan and provided recommendations not specific to the plan's focus areas or objectives.

- Continued need to attract employers to the county.
 - Specifically, by investing in infrastructure that potential employers need to establish new facilities in the county where infrastructure is currently unavailable.
 - \circ $\;$ Work to embrace new small to midsize industry locating to the county.
- While the county does a good job ensuring the health of the county's natural environment, based on recent development projects, it is important that the county continue to investigate and develop tools that can further protect the county's natural resources.
- The county's protected lands are immensely important to the community, but at this point the county has reached a maximum point of lands that can be contained in government or conservation ownership.
- The county should work to encourage more affordable housing options across the county.
- The county should continue to provide opportunities for the public to actively participate in governance, and provide direct feedback to the county on specific items of business that effect the county.
- The county should take more care to identify homelessness throughout the community and work to provide immediate aid and extinguish route causes of homelessness in the county.
- The county should look to ensure equal representation is reflected on the county's many citizen advisory councils.
- The county should investigate ways to encourage more engagement by the public at regular meetings and participation on citizen advisory councils.
- The county should look for opportunities to provide and attract affordable childcare alternatives in the community as the lack of those service is often a barrier to employment.






Figure 4 (pg. 4) of the Transylvania County 2025 Comprehensive Plan depicts regional population change and projected population change in Transylvania, and the surounding four counties. Based on data provided above, the Jackson and Transylvania County did not see the projected population growth projected in 2020.
