TRANSYLVANIA COUNTY TRANSPORTATION ADVISORY COMMITTEE MINUTES April 13, 2021, 7:01PM

I. Welcome and Introductions:

Vice Chairman Dr. John Folger welcomed all Transportation Advisory Committee (TAC) members and called the meeting to order. TAC members present were Vice Chair Dr. John Folger, Kenneth "Scott" McCall, Mark Tooley, and Jimmy Whitmire physically, while TAC members Howie Granat, RADM Richard Houck were present virtually. Aaron Bland (excused), David Carter (excused), and Keith Wilmont (unexcused) were absent from the meeting. From NCDOT, Troy Wilson, Lonnie Watkins, and Steve Williams were virtually present. From the Land of Sky Regional Planning Organization, Vicki Eastland was present virtually. Transylvania County staff present were Allen McNeill, Director, Darby Terrell, Planner, and April Alm, Transportation Planner. There were no members of the public or media present.

II. Agenda Modifications:

There were no Agenda modifications.

III. Consent Agenda:

Mr. Tooley motioned **to approve the minutes from the October meeting**. Mr. Whitmire seconded the motion, and the motion passed.

IV. New Business

A. CTP and STIP – Update

Mr. McNeill explained that the acronyms: **CTP** stands for the **County Transportation Plan** and **STIP** stands for the **State Transportation Improvement Plan**.

Ms. Vicki Eastland, the representative from Land of Sky RPO (Rural Planning Organization), the regional planning agency helped give the committee an update on the status of the CTP survey by showing an example of Yancy County who has their survey live. Ms. Eastland explained how the survey dynamics work, where citizens could find documents explaining the road projects that will be listed for Transylvania County and answered any questions that were asked by the Committee members. Ms. Eastland also updated the Committee on the recent status of the STIP projects for the County. She informed the Committee there were no current STIP updates. Dr. Folger discussed with the Committee and staff of a 2001 NCDOT Highway project report and discussed some concerns on roads that flood and the need of their improvement.

B. NCDOT Project Update

Mr. Lonnie Watkins, NCDOT representative, updated the Committee on current changes to projects under way currently and active projects that are currently on hold. Mr. Watkins answered questions from Committee members. Table below shows the projects.
